



Studio Altius is inviting photographers to submit artwork for SEEN 2007, a photography show of best work of St. Louis-area photographers in 2007. The finalists are selected by a blind jury. The First Prize will be \$200, and the top finalist in each category will receive other awards from our sponsors. The top 50 pieces will be displayed in the SEEN 2007 show at Studio Altius throughout the month of December.

The entry fee for this show is only \$10, you may enter as many times in as many categories as you wish, however, you must submit a new entry fee for every piece you enter.

Contest Rules

All entries must be dropped off or postmarked by November 9, 2007, and should be accompanied by an entry form. Finalists will be notified after November 19, 2007. Selected images will be displayed in Studio Altius for the SEEN 2007 Art Exhibition. Finalists will be required to drop off framed images by December 3, 2007, details will be given after notification of finalist status. Winners will be announced and prizes awarded at the SEEN 2007 Opening Night Gala at Studio Altius on Friday evening December 7, 2007.

Submissions will be accepted in jpeg form or photographic prints no larger than 8x12 inches. Digital file submissions should be at the file's original resolution. Digital entries must have the image title as the file name and must be burned onto a CD or DVD. Please clearly mark the CD/DVD with your name and address. Prints must be unmounted. Label each print with the image title as well as your name and address, also please indicate which edge is the top.

Each image submitted must have a separate entry form and fee (while each image requires an additional entry fee, feel free to total your entry fees on one check). Each image must be the work of the person submitting the image. Entrants under 18 years of age must submit a release from a parent or guardian. Entries will be evaluated based on appeal, content, photographic skill, and representation of the designated category. The decision of the judges is final. In the event of a tie, duplicate prizes will be awarded. Studio Altius assumes no responsibility for submissions.
